#### FATAL SEQUAL TO A FALL

An inquest was held at the workhouse Parkhurst, on Saturday by the Acting Coroner (Mr. F.A. JOYCE), on the body of **John DYER**, (86) gardener of Bank Gardens who died at the Poor Law Infirmary on the 15th inst. Evidence showed that on the 3<sup>rd</sup> inst the deceased accidentally fell backwards on the stone floor of the scullery at his home, and two days later he was admitted to the Infirmary with a fracture of the elbow joint. Doctor UNDERHILL said that the elbow was very much swollen, and that deceased was suffering from bronchitis. He attributed death to senile decay and bronchitis accelerated by the injuries received in the fall. The Coroner returned a verdict in accordance with the medical evidence.
