RYDE MAN'S DEATH IN CANADA

A good number of our readers will regret to learn of the death of a member of a well-known Ryde family, Mr **Adolphus WILLS**, assistant-superintendent of the FRASER BRACE Engineering Company at Pagan Falls, Canada, which occurred at his home 262, Laurier Avenue, East Ottawa, at the age of 39 years. He was an apprentice in the employ of Messrs. WHEELER BROS., builders etc. before he went abroad, residing with his parents at 84 Monkton Street. He will also be remembered as a member of the choir of Holy Trinity Church.

Mr WILLS has lived in Canada and the United States for the past 15 years. He was connected with the FRASER BRACE Company for many years, employed in various parts of Canada, and was a resident of Ottawa since the commencement of the GATINEAU development. He formerly worked at Chelsea, Canada, but of late was employed at Pagan Falls.

He attended the Episcopalian Church, and was a member of St Catharine's Lodge, A.F. and A.M. The local Masonic order were in charge of the funeral.

Surviving him are his widow, one daughter Margaret, aged 12 years, and his son John; three brothers and six sisters in England, a sister in India and one sister in South Africa.

The funeral took place from the chapel of George B. BURNEY and Son, Somerset Street, to Beechwood Cemetery. Around the casket was banked exceptionally beautiful and massive floral tributes, including offerings from the FRASER BRACE Engineering Company, Limited, foremen at Pagan Falls, St George's Lodge, No 15 A.F. and A.M., St Catharine's, Prince of Wales Lodge No 371 A.F. and A.M., employees of the FRASER BRACE Engineering Company, Chelsea, friends at Gatineau Mills, and FRASER-BRACE engineers, Farmer's Rapids.

The Church of England service was conducted in the chapel by Major the Rev. Channel G. HEPBURN, of All Saints Church, assisted by Rev. E. G. MAY, of the Anglican Church, Chelsea. Rev. Mr HEPBURN also officiated at the grave. At the request of St George's Lodge, A.F. of which deceased was a member, Masonic honours were accorded by Prince of Wales Lodge, Ottawa, under the direction of Mr C. R. HICKMAN, worshipful master. These included a short service in the chapel and also a service in Beechwood cemetery where, in the open grave were deposited the lambskin apron of a mason, the badge of innocence and the bond of friendship of faith and immortality of the soul.
