**DEATH OF EX-INSPECTOR MARSHALL**

The death took place at Oxley, Herts., the residence of his son, on Friday week, of **Mr. John MARSHALL**, the first inspector of the National Society for the Prevention of Cruelty to Children to be stationed in the Island. Prior to coming to the town 30 years ago Mr. MARSHALL served for 25 years in the Metropolitan Police, retiring with the rank of divisional inspector . for 17 years he was inspector of society's Island station, retiring at the age limit in 1912. Those who knew him in all parts of the Island, had a great respect for his methods. His tactfulness, patience and persuasiveness were often of great value in facilitating improvements in homes without the invocation of sterner means. Behind all his efforts there was a distinctly human touch, and long after he had retired those whom he had advised and assisted often inquired kindly after his health and welfare. Mr. MARSHALL, who was 83 years of age , was a well-known figure in those days in all parts of the Island. On his retirement he continued to live in the town until his wife's death two years ago, when he removed to Hertfordshire to take up residence with one of his sons, of whom there are four, and one daughter. The remains were brought to Ryde for interment with those of his wife on Tuesday. The first part of the service was held at Holy Trinity Church, conducted by the Rev. N.H. STUBBS (Vicar). The mourners were the deceased's four sons, and amongst those present at the church were Capt. H.J. EVANS, the society's present Inspector, Mr. F.S. ALLEN, deceased's immediate successor, who is now enjoying well-earned retirement, Mrs. HAIR, and Mrs. BALLARD, Messrs. W. WHEELER and Sons made the arrangements
