## MR W.G. DAISH, J.P.

The death occurred at his residence, The Rosary, Ratcliffe Avenue, Ryde, on Wednesday week of Mr. **William George DAISH**, aged 87. Mr. DAISH was a native of the borough, and with the exception of his student days, spent the whole of his life in Ryde, being for a considerable period in practice as a dental surgeon, keenly interested in the welfare of young people, he actively supported the work of the Y.M.C.A. Mr. DAISH devoted a loyal and valued service to the Baptist Church, supporting all spheres of its activities and holding the offices of deacon and Sunday School Superintendent. He exercised clemency and tolerance as a member of the Ryde Borough Bench over a considerable period. A few years ago he retired from the active list of magistrates, owing to increasing deafness, his name then being added to the supplementary list.
