**Death of Mrs SCOTT** – This lady, the widow of the late Mr John E SCOTT, the well known auctioneer of Ryde, expired at about 8.15 on Thursday in the 68th year of her age. Mrs SCOTT was a native on Ryde, she being the daughter of the late Mrs ALLEN. She had been suffering for the past 12 months, having had no less than ten strokes of paralysis, the last seizing her in the throat, which proved fatal. The funeral is fixed for Monday. Mr and Mrs John ALLEN SCOTT are the only surviving members of the family.
