FATAL ACCIDENT OF A TOWNSMAN

We regret to learn the death of Mr. **Louis Bernard St. John MARVIN**, son of Councillor MARVIN, of this town, in the 18th year of his age. The bright face of the manly young fellow has been missed of late, and it seems that his father, yielding to his son's wishes, allowed him to go to sea, and he was placed as an apprentice on board a large merchant vessel. On the 12th ult., while at San Francisco, we are informed that the young fellow in some way missed his footing, and fell into the hold of the ship, a considerable distance. He was picked up, and as his injuries were evidently severe he was conveyed on shore to the hospital, where he shortly afterwards expired. We feel sure that general sympathy is felt for Mr. MARVIN in his bereavement.
