### **FUNERAL OF MRS. BALLANTYNE**

The funeral of Mrs. **Polly BALLANTYNE**, wife of Mr. George BALLANTYNE, vice-chairman of the County Council, of Leslie House, The Strand, took place on Monday. A service was held at the Congregational Church, conducted by the Rev. S. PHILLIPS. The hymns "Jesu, Lover of my soul" and "We cannot think of them as dead" were sung, and the organist (Miss Gwynneth JONES) played "O rest in the Lord." The chief mourners were: Mr. BALLANTYNE (husband), Mr. and Mrs. A. BALLANTYNE (son and daughter-in-law), the Misses J. and E. CARVERS (sisters), Miss E. TAIT (niece), Miss A.L.JACOB, Mr. and Mrs. H.L. WARNE, Miss L.W. MOODY, and Mrs. D.E. CURNALL.

Others present included Brig. James HILL (representing the directors of Messrs. FRASER and WHITE), Mr. H.J. COOPER (representing the directors of Messrs. WOOD and JOLLIFFE), Ald. G.E. MEARS, J.P., Mr. E.O. KIRK, C.C., and Lt-Comdr O.W. Rees MILLINGTON, C.C., (representing the County Council, Mr. F.W. TAYLOR (secretary-manager Ryde Gaslight Company), Mr. L.G. PAYNE (secretary-manager also representing Mr. W.T. DEEKS, chairman of the East Wight Gas Company), Mr. J.P. HALL (assistant manager), Mr. A.E. WEEKS, J.P. (representing the borough magistracy), Mr. W.J.G. NEW (relieving officer), Mrs. E.O. KIRK, and Dr. G.A. UPCOTT GILL. Messrs. J.PERKIS and Son were the undertakers. The floral tributes included one from the directors of Messrs. FRASER and WHITE.

At the sitting of the Borough Bench on Monday, the Mayor (Lt-Col. C.L. ELLERY) referred to the heavy bereavement which one of their colleagues, Mr. BALANTYNE, had suffered by the death of his wife and it was agreed to send him a letter of condolence.
