FUNERAL OF THE LATE GENERAL PIGOU, R.A.

The remains of the late General **PIGOU**, R.A., were interred at the Ryde Cemetery on Monday. The body was enclosed in a very handsome polished oak coffin, on the breastplate was the inscription:

Arthur Comyn PIGOU Died December 12th, 1902' Aged 78 years.

The first part of the service was sung at All Saints' Church. The chief mourners were: Dean of Bristol, Mr. A. PIGOU and Mr. G. PIGOU (sons), Miss F. PIGOU, H. PIGOU, M. PIGOU, and sister Eveline (daughters), Nurse WALKER, Nurse REES, Annie BUTLER and Ellen BUTLER (servants), Mrs. RICHARDS, Mr. DENNETT (Park Gardens), Mr. CASS, Mr. HAYLES, and Mr. SYLVESTER.

Amongst those present in the church were the Revs. W.F.J. HANBURY, and O.Y. BULKELEY, Dr. J.D. DAVIES, Capt. UNDERWOOD, Mrs. H. STONE, Miss MURREY, Miss BARRY, and Mr. TOMS. The hymns "Nearer my God to Thee", "Now the labourer's task is o'er." And "On the Resurrection morning" were sung. The Vicar (the Rev. J. SHEARME) officiated. Dr. MANDER played the "Dead March" in *Saul* as the body was being removed from the church. At the Cemetery, Ald. GROVES, J.P., and Mr. H. SWEETMAN, J.P., were also present.

There was a magnificent floral cross of orchids, chrysanthemums, lilies and other white flowers on the coffin. Cecil DANIELL, Mr. and Mrs. Edward CARTER, Lieut. Col. and Mrs. F.
