DEATH OF MRS. M. L. WEARN

Loved and respected by all who knew her, Mrs. **Mildred Louise WEARN**, of Coniston, Salisbury Road, died at St. Mary's Hospital, Newport, on Saturday, aged 77. A native of Cowes, Mrs. Wearn was the widow of Mr. William Charles WEARN, former head master of the Central School, whom she met when she was training to be a teacher at a college in Winchester. Prior to the first world war she moved to Wroxall, where her husband was head master of the local council school, and when he joined the Army she took over the duties as head of the school. During her residence at Wroxall Mrs. WEARN took an active part in village affairs, particularly in connection with the work of the Parish Church. She came here in 1925 when Mr. WEARN took up the appointment as head master of the Central School.

The funeral took place on Tuesday at St. John's Church, the Vicar (the Rev. A. J. PEARMAN) officiating and Mr. R. H. TOOGOOD (organist) played "The Lord's my Shepherd" to the tune of Crimond. The mourners were Mr. W. H. WEARN (son), Mrs. J. LEIVERS (daughter), Mr. and Mrs. J. R. PERKINS (son-in-law and daughter), Mrs. A. WELLS (sister-in-law), Mr. W. WEARN (nephew), Mr. M. PERKINS (grandson), and Mrs. W. NEWNHAM. Interment was at the Cemetery.
