40 YEARS SERVICE
WITH RYDE CONFECTIONERS
MR. H. W. SCOVELL DIES AGED 62

Almost 40 years continuous service with a firm of Island confectioners was the record of Mr. **Henry William SCOVELL**, aged 62, who died at Ryde Nursing Home on Saturday. His home was at 56 Asheyy-Road, Ryde. Mr. SCOVELL was a native of Ryde, and joined the confectionery firm of Messrs. Brighton, ROGERS & Co. Ltd., in Monkton-Street, Ryde, at the age of 13, and became a sugar boiler. He enlisted with the I.W. Rifles in 1914 and served until the end of the first world war. He was at the Battle of Gaza in 1917 and later wounded and taken prisoner by the Turks.

As a young man Mr. SCOVELL lived at Elmfield, and was a member of St. John's Church where he was head server for 12 years. After his marriage 28 years ago he went to live at Asheyy-Road. He later joined All Saints' Church, and was a former sidesman and member of the church council.

Mr. SCOVELL leaves a widow and one son. The funeral service took place at All Saints' Parish Church yesterday afternoon.

The funeral service was conducted at Ryde Parish Church on Wednesday last week for Mr. **H.W. SCOVELL**, who died at Ryde Nursing Home the previous Saturday. Mr. SCOVELL, whose home was at 56 Asheyy-Road, Ryde, served for nearly 40 years with a firm of Island confectioners, Messrs. Brighton, ROGERS and Co. Ltd. Attending the funeral were the managing director of the firm, Mr. F. SALTER, other directors, and colleagues of Mr. SCOVELL, who also sent floral

tributes. More than 50 tributes were received.
