## WILLIAM JAMES - THE LAST WILL AND TESTAMENT

This is the last Will and Testament of me William James of Binstead in the Isle of Wight quarryman, made the seventh day of January one thousand eight hundred and sixty five. I give and devise all my real and personal estate and effects whatsoever and whatsoever unto my brother in law William Twyman and my brother John James their heirs executors adminstrators and assigns in trust to permit my wife to receive the rents interest and annual proceeds thereof during her life or widowhood and after the decease or marriage of my said wife I direct my trustees to sell my real estate together or in parcels by public auction or private contract and to ...... and get in my personal estate and I direct my trustees to stand possessed of the monies to arise from my real and personal estate in trust for and I give the same unto all and every my children who shall live to attain the age of twenty one or die under that age leaving lawful issue in equal shares of more than one and if but one then upon trust for and I give the same to such one child while such share shall be contingent and to apply the whole or a oart of the annual income thereof for the maintenance and education of such child accumulating the unapplied income by investing the same I empower my trustees to give receipt for all moneys paid to them by virtue of this my will and declare that such receipts shall exonerate the persons taking the same from all liability to see to the application of the money therein mentioned to be received. And I declare that my said trustees shall be answerable for their own respective wilful acts receipts and defaults only and shall be at liberty to retain and allow to each other out of the moneys coming to their hands by virtue of theis my will all expenses incurred in executing the trusts thereof I appoint my said Brother in Law William Twyman and my said brother John James Executors of this my Will and I revoke all former wills by me made and declare this to be my only true last Will and testament. In witness whereof I have hereunto subscribed my name the day and year first before written – William James – Signed acknowledged and declared by the said William James as and for his last Will and testament in the joint presence of us who at the same time in his presence have subscribed our names as witnesses – G. Rochfort- E Urry.-

On the 20<sup>th</sup> day of Dec. 1886 probate of this Will was granted to William Twyman, one of the executors.-
