DEATH FOLLOWS FALL

The Coroner (Mr. R. E. A. WEBSTER) held an inquest at St. Vincent's, Barfield, on Friday week, on Mrs. **Louisa Amy MOORE**, aged 87, widow of Mr. Theodore MOORE, a retired architect. Mrs. MOORE died at the house on Thursday week.

Miss Elizabeth Helen BURVILLE, of 16 Trinity Street, said that Mrs. MOORE, for whom she worked, was well before the accident.

Miss Edith Mary SKINNER, of Flat 1, Eastfield, Dover Street, said she had been a friend of Mrs. MOORE for 15 years. On October 1st she had tea at St. Vincent's, and afterwards heard a fall in the kitchen, and Mrs. MOORE called out. She found her on the floor, and she said "I think I've broken my leg." Witness helped her into a chair and summoned Mr. F. WILSON HARLOW and the district nurse. Mrs. MOORE told her she had slipped.

Mr. WILSON HARLOW said Dr. H. SUTHERLAND had rendered first aid when he arrived, and an X-ray examination confirmed that there was a fracture of the neck of the left femur. Mrs. MOORE's general health deteriorated, her heart began to fail and hypostatic pneumonia developed.

The Coroner recorded a verdict that death was due to hypostatic pneumonia, following the injury sustained in an accidental fall.

The funeral took place on Tuesday. The Vicar (Canon A. CORY) conducted the service at All Saints' Church, and Mr. W. L. REED (organist) accompanied a hymn. The mourners were Mr. J. P. ASHBRIDGE, Sir Noel ASHBRIDGE, and Mr. and Mrs. P. M. ASHBRIDGE (nephews and niece), and others present included Mr. and Mrs. D. G. TIMS, Mr. F. WILSON HARLOW, and the Misses MORTON and SKINNER. The interment was at Ryde Cemetery.

Messrs. LANGDON made the arrangements.
