### SUDDEN DEATH

Mr. **Jeremiah THORNTON**, aged 65, of 29, St. John's-Road, who for many years has been the foreman at the I.W. Railway Works, St. John's-Road Station, fell down outside the station on Monday morning, at about half past 11, and was taken to his home, where he shortly afterwards expired. Deceased had been attended by Dr. WOODS, of Sandown, for varicose veins and had been seen by that gentleman on the previous day, when he seemed his usual general health. Death is attributed to heart failure. No inquest was necessary.

The funeral took place at the Cemetery on Thursday afternoon, the Rev. W.M. CAMERON officiating. A very large number of railwaymen attended, including Mr. H.K. DAY, secretary and manager of the I.W. Railway Company, Mr. H. BRENT, Messrs. WILLIAMS (Newport), GREGORY, DAISH, BENCH, WETHERICK, CORBETT, BURGESS, HOLT, and HOPGOOD.

There were flowers from the traffic department of the I.W. Railway, Mr. H. BRENT, Mr. A. HOFFMEISTER, Mr. and Mrs. F. BUCKETT, Mr. and Mrs. GAPE and family, Mr. C.S. DENTON, and Mr. J.H. SEYMOUR.
