THE LATE MRS. SPENCER.

The death took place on Monday of Mrs. **Sarah Maria SPENCER**, of Bassett Lodge, Well-street, aged 88. She was a member of an old Ryde family, the widow of

Mr. Thomas George SPENCER, and mother-in-law of Ald. A. F. WRIGHT, J.P. Mrs. SPENCER had enjoyed excellent health until a fall in her house, which was the subject of an inquiry by the Deputy Coroner (R. E. A. WESTER, Esq) on Wednesday. Mrs. Ethel Mary WRIGHT, of Ladbrooke, Belvedere-street, (deceased's daughter), deposed that her mother informed her on December 19th, that she had fallen through slipping on a mat in the hall. Deceased received constant medical and nursing attention. Dr. T. SIM said deceased fractured her right thigh and for some days made good progress, but later her health failed and she died from hypostatic pneumonia aggravated by the shock of the fall. The Coroner returned a verdict accordingly. The funeral was on Thursday, the first part of the service being held in the Parish Church, Canon R. S. MOXON officiated, assisted by the Rev. F. H. ROLPH, and the hymn "On the resurrection morning" was sung. The chief mourners were Mrs. A. F. WRIGHT (daughter), Mr. Thomas SPENCER (son), Ald. A. F. WRIGHT and Mr. S. SMITH (sons-in-law), Mr. and Mrs. Tannahill GIBSON (nephew and niece), Miss BURDEN (companion), and Mrs. VESSEY. Owing to illness Mrs. S. SMITH (daughter) was unable to be present and the other son, Mr. G. A. SPENCER, is in South Africa. The interment was at the cemetery and floral tributes were sent by the following: Bert and Ethel; Tim and Winnie; Sid, Ivy and family; George, Jessie and family (South Africa); Patsy, Bee, Joyce, John, and Percy; Peggy, Gibby, and family; Mrs. FIELDWICK and family, Hindhead; All at 2a Argyll-street; her companion May; Clarice and Reg; Mrs. WRIGHT and Louie; and Mr. and Mrs. FARMER.
