FATAL RESULT OF A FALL

At the County Hospital, Ryde, last night, Major B. P. WILTON (Acting Coroner) held an inquest on the body of George ELDRIDGE, 69 years of age, a plasterer, in the employ of Mr. C. LANGDON, on whose behalf Mr. J. FARDELL watched the proceedings. –Edward CHESSLE, a labourer, said that he and deceased went on the morning of the 23rd ult. To repair the roof of Westwood, Argyle-street. Finding their ladder too short they lashed another, which they found on the premises, to it. Witness noticed that the latter was defective and advised deceased not to ascend it. He did so, however, with the result that the ladder broke and collapsed, deceased falling to the ground and fracturing his right leg. He was removed to the Hospital, where he died on Wednesday. –Dr. Peter WARD, house surgeon, attributed death to septic pneumonia, following upon the accident. -The Coroner characterised the deceased's conduct as foolhardy. The jury returned a verdict in accordance with the medical testimony, and exonerated deceased's employer from all blame. –Mr. FARDELL voiced his client's deep regret at the loss of an old and faithful employee, and his sympathy with the widow and relatives. –Mr. Frederick HOLT, foreman of the jury, also expressed sympathy wuith the bereaved.
