The late Mr. A. GIBSON.- For many years one of the town's best known tradesmen, Mr. Alfred GIBSON, passed away at his residence, Coromandel, Bellevue-road, on Saturday. Had he lived until February 15th. he would have celebrated his 99th birthday. He was a long time in business in the Highstreet as a boot and shoe dealer, but retiring some 11 years ago whilst still alert in mind and most active in body. Long after he passed into his 90th year Mr. GIBSON continued to do much walking. He was probably one of the oldest freemasons in the country and certainly had the distinction of being the oldest member of the east medina Lodge 175.

The funeral was at the cemetery on Tuesday preceded by a service in the house. The Rev. H. B. WORTHINGTON officiated and the mourners were Mrs. GIBSON (widow), Mrs. Harold and Mrs. Ronald GIBSON (daughters-in-law), Mr. Urban ROSE (nephew), of Stradhampton, Oxford, Mrs. Lucy PENNY, of Oxford, Mr. Yorke LOWE, of Tadley, Mrs. MANFIELD, and Mr. FLEMING. Deceased's surviving son, Flying Officer Harold GIBSON, was unable to be present, being on service. Others present were Miss LANGDON, Bros. W. G. F. SUTTON (W.M.), C. LANGDON, O. J. FEBEN, F. A. BRICKELL, and H. GAGE (the East Medina Lodge), and Dr. L. FIRMAN-EDWARDS (Ryde Lodge 698). There was a number of choice floral tributes.

Mr. C. LANGDON was the undertaker.
