DEATH OF COLONEL HOWARD-BROOKE.

It is with very sincere regret that we have to announce the death of Colonel **Richard Edward Frederick HOWARD BROOKE**, J.P., of Faircroft, Ryde, and Castle Howard, Oroca, Co. Wicklow, and Roskelton, Queen's County, who passed away at his Ryde residence on Sunday, after a lengthy illness, at the age of 71, having been born on November 1st, 1847.

The deceased gentleman entered the Army while yet in his teens, and held a distinguished record of service. Possessed of qualities that make for popularity, warm-hearted and open-handed, he was popular alike with his brother officers, and the men serving under him. In 1878, he married Miss Alice Eliza RIDLEY, daughter of the late Mr. Samuel RIDLY, of St. Helens, and has for many years been a leading figure in Island society. He interested himself in all matters connected with the Island, and was ever ready to give time and service to any effort being made to advance Island interests. A thorough sportsman, he for some years held the position of master of the Isle of Wight Foxhounds. All his public duties were discharged with the thoroughness and wholeheartedness that were characteristics of the deceased gentleman, and he devoted himself unsparingly to whatever he took in hand. As a magistrate he took his duties seriously and discharged them faithfully. Genial and kindly he always had a bright smile and cheery word for everybody, no appeal for help was ever made to him in vain and the extent of his benefactions will never be fully known. He was one of the most popular members of the Royal Victoria Yacht Club, Ryde, and his lamented death has left a void both in the public and the social life of the Island that it will not be easy to fill. As a working man remarked to the writer on Monday, "Colonel HOWARD BROOKE was one of the best, and he will be missed and wanted too." The sympathy of a wide circle of friends will go out to the bereaved and sorrowing family. The funeral takes place tomorrow (Thursday) at 12 o'clock mid-day at All Saints' Church.

DEATH OF COL. HOWARD-BROOKE, J.P.

It is with deep regret that we have to record the death of Col. HOWARD-BROOKE, J.P., Q.C., which occurred on Sunday evening at his residence, Faircroft, Binstead Road, Ryde. A better known, or more popular sportsman, in the true sense of the word, has, we venture to say, never been identified with the Island. His geniality, kindness of heart, and thought for others were prominent characteristics of many sterling qualities. Born at Castle Howard, Co. Wicklow, Ireland, on the 1st

Nov., 1847, at the age of eighteen he joined the Army, and as a Lieutenant in the 37th regiment, served for ten years in India. There he became known as an exceptionally keen big-game hunter. and on one occasion, with General Sir John DAVIS, bagged no fewer than seventeen tigers in seven days. The deceased gentleman married, in 1878, Miss Alice Eliza RIDLEY, daughter of the late Mr. Samuel RIDLEY, The Castle, St. Helens, and at the same time took up his residence at Ryde, and for some years lived at Little Apley. His connection with the Isle of Wight Foxhounds, of which he was the popular and genial master for twenty-five years, brought him in close touch with the agriculturalists of the Island, by whom, in common with all who knew him, he was held in the highest respect and esteem. He was a member of the Royal Victoria Yacht Club, the Royal I.W. Golf Club (of which he was captain in 1882), the I.W. Gun Club and the United Services. As a Justice of the Peace for the County of Hampshire, he was very regularly when in the Island in attending the sittings of the Bench of Magistrates, both at Newport and Ryde. For two years, 1900-2, he was a member of the Ryde Town Council, and during recent years he has been one of the representatives of the borough on the I.W. County Council. The late Col. was politically a staunch Conservative and was a Vice-President of the Conservative and Unionist Club, Lind Street. Although laid aside with a painful malady, the deceased bore his sufferings with remarkable fortitude, and the keen sense of humour, which he always manifested, was present with him almost to the last, death taking place at 8.25 on Sunday evening. Deceased had no family, but leaves a widow, for whom sincere sympathy has been expressed in her sore bereavement.

At the weekly sitting of the I.W. County Justices at Ryde, on Tuesday, Mr. W. A. The funeral rites at the cemetery carried out in a downfall of rain, were performed by the Rev. Cyril L. BLAKE.
