**MISS E. H. HURRELL**

We regret to announce the death on Thursday last of Miss E. LEIFCHILD HURRELL, aged 86, at 45 Argyll Street. Miss HURRELL came to Ryde about 10 years ago and took a great interest in all religious work, especially foreign missions. She was herself a missionary in Italy some years ago. She was a prolific writer of Religious Poems, of which six volumes have been published and widely distributed. She passed peacefully away after an illness which lasted nearly 15 months.

The funeral service was held at St. James' Church on Monday, the Incumbent, the Rev. E. E. M., GREEN, officiating. Miss HURRELL's favourite hymn "O love that will not let me go," was sung. Her remains were interred at Ryde Cemetery. Among a large number of mourners were Mr. and Mrs. H. COLLYER, Miss Isabel ROY, Mr. N. B. COLLYER, Miss OSBORNE, Nurse ROSE, Miss PERKINS, and Miss THORNLEY.

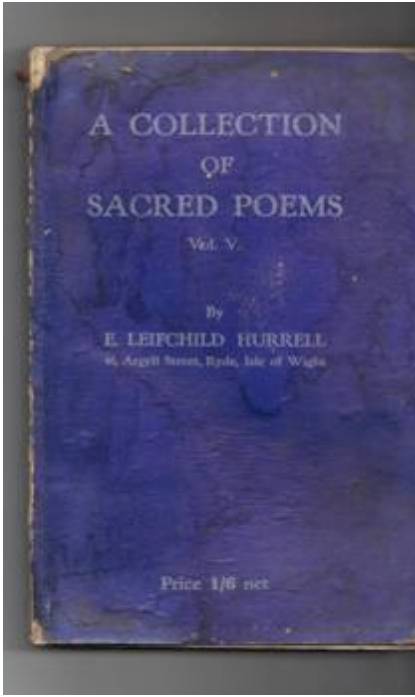

**A COLLECTION OF SACRED POEMS. Vol.1V. By E. Leifchild Hurrell. London. *Thynne & Jarvis, Ltd.* Cloth, 1s.6d. net.**

Miss Hurrell's output is tremendous! This is the fourth volume of her poems. They are saturated through and through with Holy Scripture. Many of them are of very considerable merit and some of them fasten attention on obscure passages. Mr. Wilkinson, of the Mildmay Mission to the Jews, contributes an appreciative forward, commending them for their "very direct and faithful message" - praise they very well deserve.
