**Nonagenarian's Accidental Fall.**- On Saturday at the Newport-street Methodist School the Deputy Coroner (Francis A. JOYCE, Esq.) held an inquiry into the death of Mrs. Caroline LILLEY, aged 90, of 9 The Alms Houses, Newport-street, whose death took place on Thursday week following a fall.- P.S. LOCK and P.C. MAYBURY represented the police.

Eliza SHERLOCK, widow, aged 70, of 24 Warwick-street, daughter of the deceased, said the latter had been a widow since 1880. Her mother had spent most of her life in Ryde and for 10 years had resided at the Alms Houses. On Oct. 2nd witness was in the living-room with her mother, who went to fetch a scuttle of coal from the coalhouse in the passage. When passing through the door on returning she fell and struck her left side on the bed. Witness assisted her into a chair in a dazed condition and sent for a doctor. She remained with her mother for a month and then her sister relieved her. Her mother progressed for a while, but on Nov. 12th she was gradually becoming worse, and died on Thursday.

Dr. Walter SHANKS, of John-street, said he had been in daily attendance on deceased since her accident. Her ribs were cracked, but not fractured. After the pain had subsided her condition improved from time to time, but she had almost weekly relapses with a slight rise of temperature that developed hypostatic pneumonia. On Nov. 12th she had another relapse and went into a comatose condition, from which she never recovered.

The Coroner recorded a verdict of accidental death and said he was quite satisfied that deceased had been well taken care of by her daughters and the doctor, and that everything possible had been done for her.
