DEATH DURING AN OPERATION.

Most of the London papers last week-end had a reference to the fact that two doctors disagreed at a Westminster inquest, held on Saturday, on the body of **Amelia Jane (Millie) NEWMAN**, 26, of Ryde, who died in St. George's Hospital while undergoing an operation for goitre. Dr. **JEWsbury**, pathologist at Charing Cross Hospital, who made a post-mortem examination, said he could not dissociate the anaesthetic from the death; which was due to syncope. Dr. Frederick **LONGHURST**, however, disagreed that the anaesthetic contributed to death, contending that deceased would have died even if the anaesthetic had not been administered. In returning a verdict of "Death by misadventure" the jury found that the operation was necessary, and that the anaesthetic was efficiently administered. Deceased was the eldest daughter of the late Mr. G.R. **NEWMAN** and Mrs. **NEWMAN**, of Stanley Cottage, George-street. She had been employed at Messrs. H. **PACK** and Co.'s for some years. Heart trouble developed, and Dr. **TURNER** had attended her previous to her going to St. George's Hospital at the beginning of October.

The funeral took place at the Ryde Cemetery on Tuesday. The first part of the service was held at Holy Trinity Church, where the deceased had been a worker for many years, particularly in connection with the Sunday-school. The Vicar (the Rev. J.E. **EDDIS**, R.D.) and the Rev. Noel H. **STUBBS** officiated. The principal mourners were Mrs. **NEWMAN** (mother), Miss Rose **NEWMAN** (sister), (P.O. George **NEWMAN**, the brother, who is in the Navy, was unable to be present), Mr. C. **BICKELL**, Mrs. **HANRAHAM**, Mr. Leonard **NEWMAN**, Mrs. **SHAWYER**, and Miss **FREEMAN**. There were floral tributes from mother, brother and sister; Aunt Annie and Uncle Charley; Uncle Charley, Aunt Minnie, and Uncle Len; her fellow workers at Messrs. **PACK** and Co; Allin and Aileen; Mr. and Mrs. E. **ALLEN**; Aunt Alice and cousins; in loving memory of our dear teacher, G. **HACKSHAW**, E. **SCOVELL**, G. **TERNER**, and E. **LEAL**; Mr. and Mrs. W. **MUNDAN**; Mr. and Mrs. J. **SWEETMAN**; Mrs. A.A. **HOLLAND**; A.E. and H.E. **COOMBES**; Mr. F. **BEVIS**, Arthur, and Bertie; Holy Trinity Girl's Club; superintendent and teachers at Holy Trinity Sunday-school; Amy, Edith, and Mary; her two aunts, Rose **NEWMAN** and Annie **ALLEN** (London); the Rev.
