A PATHETIC COINCIDENCE. – Within a few hours on Monday two families closely related by marriage were sent into mourning. In the early hours of the day Mr. Thomas FEAVER, who lived with his married daughter at 13 Abingdon-road, passed away at the great age of 86. A few hours later his daughter lost her husband, Mr. Francis Henry STICKLAND, who died at the same address. Mr. STICKLAND, who was 56 years of age, was very well known by his long connection with the firm of Messrs. James WATKINS and Co., leather merchants, of High-street, in whose employ he started as a boy and rose steadily to become the manager, a position he held with their fullest confidence until ill-health caused him to vacate the post some months ago. His father-in-law was one of the few remaining old coach drivers and a native of Ventnor. In addition to his widow Mr. STICKLAND leaves two sons and two daughters, with whom and the other members of the family, the deepest sympathy is felt. Additional pathos is lent to the sad coincidence by the fact that Mr. STICKLAND's mother is at present a patient in the County Hospital as a result of being knocked down by a motor-car and not yet in a fit condition to be informed of her son's death. The double funeral took place at the Cemetery on Thursday, the Rev. N.H. STUBBS (vicar of Holy Trinity) officiating.
